

## 2023 BEACH BAR TO SANDBAR BLUE CHAIR BAY SWEEPSTAKES

### OFFICIAL RULES

**MUST BE 21 TO ENTER. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. AFFIDAVIT OF ELIGIBILITY/ RELEASE OF LIABILITY AGREEMENT REQUIRED. VOID WHERE PROHIBITED.**

**DESCRIPTION AND SPONSOR:** The 2023 Beach Bar to Sandbar sweepstakes (the “Sweepstakes”) begins at 12:01 a.m. Pacific Time (“PT”) on February 15, 2023 and ends at 11:59 p.m. PT on April 30, 2023 (the “Sweepstakes Period”). The Sweepstakes is sponsored by Fishbowl Spirits, LLC, Nashville, TN (the “Sponsor”), and administered by Savvy Drinks, LLC (“Administrator”) (collectively, the “Sweepstakes Entities”).

**ELIGIBILITY:** The Sweepstakes is open to legal residents of the fifty (50) United States and Washington D.C., who are at least 21 years of age or older as of the start of the Sweepstakes Period. No purchase is required to enter or win the Sweepstakes. No more than one (1) entry per natural person/email address/phone number. Limit one (1) prize per natural person/household. The Sweepstakes is void in Puerto Rico, the U.S. Virgin Islands, U.S. Military installations in foreign countries, all other U.S. territories and possessions, and wherever else restricted or prohibited by law. Employees and officers of the Sweepstakes Entities, their parents and subsidiaries, advertising and promotion agencies and all other persons or entities participating in the design, promotion, marketing, advertising, administration, or fulfillment of the Sweepstakes, and their immediate families (i.e., spouse, parent, child, sibling and their respective spouse) and persons living in the same household of each are ineligible to participate in or win the Sweepstakes. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, non-California residents can obtain an image of a palm tree pattern (“Palm Tree Strip”) under the tamper tape on any bottle of Blue Chair Bay Mocha Rum Cream, or go to <http://www.beachbartosandbar.bluechairbayrum.com/> (the “Website”) to download a free Palm Tree Strip. (CA residents must download the Palm Tree Strip from the Website.) Entrants can enter using the Palm Tree Strip as described below.

During the Sweepstakes Period, Entrants can view the Official Rules by visiting the Website. There is one entry method for the Sweepstakes (the “Entry Method”). **Entrants must register prior to being able to use the Entry Method.** To register, go to the Website, provide your date of birth, state of residence, name, address, and e-mail address and follow the on-screen instructions. **No more than one (1) entry per person/household/email address/mobile device number per day.** Multiple daily entries will automatically result in disqualification. You will receive one (1) Entry into the Sweepstakes, upon successful completion of your registration and your successful Sweepstakes Submission on any day during the Sweepstakes Period. Only one (1) Entry per person per day during the Sweepstakes Period is allowed. Duplicate or multiple daily Entries will disqualify all such Entrants. In the event of a dispute regarding the number of Entries received from an entrant, the decision of Sponsor shall control and be binding. **Only online Entries submitted through the Entry Method will be accepted for the Sweepstakes.** No hand, mail-in or e-mail deliveries will be accepted. Incomplete, garbled, corrupted or otherwise illegible Entries are void and will not be accepted. Sponsor reserves the right to disqualify false Entries or Entries suspected of being false in its sole and absolute discretion. **THE SWEEPSTAKES PRIZES:** There will be one (1) Grand Prize awarded at random following the conclusion of the Sweepstakes Period (“Sweepstakes Grand Prize”). The Sweepstakes Grand Prize will consist of a trip to Orange Beach, AL to Kenny Chesney’s, I Go Back Tour, and shall have an approximate retail value (“ARV”) of three thousand dollars (\$3,000) The components of the Sweepstakes Grand Prize are:

- Round-trip standard economy airfare for two (2) people to a major commercial airport near Orange Beach. The departing and returning flights will be based out of the major U.S. airport hub closest to the Sweepstakes Grand Prize Winner’s place of residence, or at the Sponsor’s discretion.
- Three (3) nights’ stay for two (double occupancy, standard room) in hotel to be chosen by Sponsor.
- Round trip transportation to and from the airport and the hotel chosen by Sponsor.
- Two (2) sandbar tickets to Kenny Chesney’s I Go Back Tour in Orange Beach, AL, on or about May 27, 2023.
- A five hundred dollar (\$500) VISA® gift card to use for activities at the beach in Orange Beach, AL.

There will be five (5) First Prizes awarded at random following the conclusion of the Sweepstakes Period (“Sweepstakes First Prizes”). Each of the First Prizes will consist of one (1) wrapped guitar signed by Kenny Chesney. Each First Prize shall have an ARV not exceeding \$600.

There will be ten (10) Second Prizes awarded at random following the conclusion of the Sweepstakes Period (“Sweepstakes Second Prizes”). Each of the Second Prizes will consist of one (1) Mocha Rum Cream swag bag. Each Second Prize shall have an ARV not exceeding \$150.

**ARV OF THE SWEEPSTAKES PRIZES:** Total ARV of all prizes is \$7,500. ARV of prizes calculated as of the date of printing of these Official Rules. Actual value may vary based on point of departure and airfare fluctuations. Any difference between stated approximate retail value and actual value of Prize will not be awarded.

**PRIZE CONDITIONS:** The Sweepstakes Prizes do not include alcoholic beverages. Sponsor reserves the right to make all selections regarding the contents of the Sweepstakes Prize. All prize details not specified in the Official Rules will be determined in Sponsor’s sole and absolute discretion. Travel and hotel accommodations are subject to capacity controls, availability, blackout dates and other restrictions, all of which are subject to change at Sponsor’s sole discretion. The Sweepstakes Winners will be responsible for the taxes associated with airfare at the time of booking. Airline tickets are non-transferable.
